Greater Madison Metropolitan Planning Organization (MPO) November 6, 2024, Meeting Minutes

Virtual Meeting hosted via **Zoom**

Opitz called the meeting to order at 6:32 p.m.

1. Roll Call and Introductions

Members present: Clement Abongwa, Richelle Andrae, Liz Callin, John Duncan, Paul Esser, Derek Field, Thomas Lynch, Mark Opitz, Art Sommerfield, Kristi Williams, Doug Wood

Members absent/excused: Phil Caravello, Barbara Harrington-McKinney, Charles Myadze

MPO staff present: Alex Andros, Kayla Haas, Bill Holloway, Ben Lyman

Others present in an official capacity: None.

2. Approval of October 2, 2024, Meeting Minutes

Williams moved, Abongwa seconded, to approve the October 2, 2024, meeting minutes. Motion carried.

3. Communications

Andros stated that she had just received a letter (dated November 5, 2024) from WisDOT approving the MPO's most recent TIP amendment.

4. Public Comment (for items not on MPO Agenda)

None.

5. MPO 2024 Resolution No. 21 Approving 2025 Unified Planning Work Program

Andros said that the draft unified planning work program (UPWP) that had been previously reviewed by the MPO Policy Board was reviewed by WisDOT and FHWA. She said that they offered few comments about anything other than what the MPO was already planning to change. Those are listed on the change sheet, included in the meeting packet.

FHWA is still working on guidance for how the MPO should use Safe and Accessible Transportation Options funding and they will be asking MPOs to amend their UPWPs in the first quarter of 2025 to accommodate that. The MPO also received complements on how the UPWP was put together.

Other key changes to the UPWP include the active transportation plan being pushed into 2025 to coordinate with the City of Madison's active transportation plan and the transportation systems management and operations (TSMO) plan being delayed—due in part to Colleen's departure. The MPO is working closely with the City of Madison Traffic Engineering Department on putting together an RFP for a consultant to help us with the TSMO plan.

MPO staff recommended approval of the resolution.

Esser moved, Wood seconded, to approve MPO 2024 Resolution No. 21 Approving the 2025 Unified

Planning Work Program. Motion carried.

6. MPO 2024 Resolution No. 22 Approving the 2024-2028 Coordinated Public Transit – Human Services Transportation Plan for Dane County

Lyman said that the Board had seen the draft a month ago and that since then there had been only one substantive comment received on the plan calling for a couple of changes to highlight the need for better transportation between Dane and Rock Counties. This change is in keeping Rock County's most recent coordinated plan, which calls for improved transportation between the two counties.

Duncan moved, Williams seconded, to approve MPO 2024 Resolution No. 22 Approving the 2024-2028 Coordinated Public Transit – Human Services Transportation Plan for Dane County. Motion carried.

7. MPO 2024 Resolution No. 23 Adopting Annual Federal Safety Improvement Performance Measure Targets

Andros said that adopting the federal safety improvement targets is required. She noted that some of the transit targets cannot be set because it requires three years of data, which the MPO lacks because the data is only available back to 2023.

Lynch moved, Duncan seconded, to approve MPO 2024 Resolution No. 23 Adopting Annual Federal Safety Improvement Performance Measure Targets. Motion carried.

8. MPO 2024 Resolution No. 24 Amending the 2025-2029 Transportation Improvement Program for the Madison Metropolitan Area & Dane County to Revise Attachment E to Incorporate Reference to the 2025 Federal Safety Improvement Performance Measure Targets

Andros said that this would include targets for the number and rate of fatalities and serious injuries, and the number of non-motorized fatalities and serious injuries. She said that MPO staff recommended approval.

Esser moved, Williams seconded, to approve MPO 2024 Resolution No. 24 Amending the 2025-2029 Transportation Improvement Program for the Madison Metropolitan Area & Dane County to Revise Attachment E to Incorporate Reference to the 2025 Federal Safety Improvement Performance Measure Targets. Motion carried.

9. MPO 2024 Resolution No. 25 Authorizing the Greater Madison MPO to Submit a Grant Application to the United States Department of Transportation for up to \$15 million for Low-Carbon, High Reward: Uniting Local Communities Toward Low-Carbon Infrastructure Materials

Andros described the Low-Carbon Transportation Materials grant program, the short timeline for applications, and the MPO's efforts to assess how and whether to pursue the grant.

She said that she had just spoken with WisDOT staff about the potential grant project and that, following that discussion, she felt that continuing to pursue the grant would not be a good use of the MPO staff time nor the time and effort that would be required from other grant partners. She said her main concerns were that WisDOT would not be able to assist the MPO in the project, local government engineering staff would be reluctant to use specifications developed separately from WisDOT, and that the MPO lacks the engineering expertise to oversee consultants doing the work.

Abongwa noted that his engineers had already put a lot of work into preparing to apply for the grant. And he asked Andros to provide feedback to FHWA to let them know how much effort had been expended trying to prepare to apply for this grant and that FHWA should provide more clarity about these types of grants in the future to avoid this type of confusion and wasted effort.

Esser moved, Callin seconded, to approve MPO 2024 Resolution No. 25 Authorizing the Greater Madison MPO to Submit a Grant Application to the United States Department of Transportation for up to \$15 million for Low-Carbon, High Reward: Uniting Local Communities Toward Low-Carbon Infrastructure Materials. Motion failed.

Field moved, Andrae seconded, to indefinitely postpone consideration of MPO 2024 Resolution No. 25 Authorizing the Greater Madison MPO to Submit a Grant Application to the United States Department of Transportation for up to \$15 million for Low-Carbon, High Reward: Uniting Local Communities Toward Low-Carbon Infrastructure Materials. Motion carried.

10. Announcements and Staff Reports

Andros said that she was working on hiring a new staff member to fill Colleen's old position. The first candidate offered the job had not accepted and she was in the process of negotiating with the second. She noted that the MPO was lucky to have three excellent candidates for the job and that she expected to have the new candidate onboard by late November or early December.

11. Adjournment

Esser motioned, Wood seconded, to adjourn. Motion carried. Meeting adjourned at 6:39 p.m. The next Policy Board meeting will be held virtually on Wednesday, December 4th, 2024.

WHEREAS, the staff of the Greater Madison MPO (Metropolitan Planning Organization) has historically provided assistance to Dane County for specialized transportation planning and coordination services; and

WHEREAS, the MPO intends to continue this assistance of planning and coordination services to the county again in 2025; and

WHEREAS, the County has budgeted \$5,000 for this service for the year 2025; and

WHEREAS, this service is included in the Greater Madison MPO's adopted 2025 Unified Planning Work Program; and

WHEREAS, the County requests that this agreement be part of Metro Transit's service agreement and contract for transit information, promotion efforts, and operations, since the contracting agent for both Metro Transit and the MPO is the City of Madison; and

WHEREAS, the services to be provided by the MPO and Metro Transit are outlined in the attached scope of services document:

NOW, THEREFORE, BE IT RESOLVED that the Greater Madison MPO agrees to have MPO staff provide this service to Dane County in 2025 and authorizes the City of Madison on behalf of the MPO to execute the agreement and contract to provide this service.

DANE COUNTY FUNDED 20245 PUBLIC TRANSIT SERVICES PROVIDED BY METRO TRANSIT AND SPECIALIZED TRANSPORTATION COORDINATION SERVICES PROVIDED BY GREATER MADISON MPO

Schedule A: Scope

Public Transit Services. Dane County will fund the following public transit services of the City of Madison to be provided by Metro Transit.

1. Assistance to Customer Service Center (CSC)

The major area-wide information point for transit has been Metro's Customer Service Center, which provides information on routes, schedules, etc., for those who telephone and responds to E-mail questions regarding routes and schedules. CSC representatives also provide paratransit ride scheduling, transportation referrals, and ridesharing (266-RIDE) referrals for vanpool and carpool services. Representatives utilize Teleinterpreters for interpretation services when callers who speak only foreign languages contact the CSC.

2. Transit Information/Promotion Assistance

Provide assistance to Metro Transit for transit information and promotion costs including:

- Printing map and schedule information.
- Promoting Commute Card <u>passes</u>, <u>Fast Fare cards</u>, and <u>Fast Fare Senior/Disabled</u>
 discount cards. pass and existing prepaid fares such as 31-Day, 31-Day Senior/Disabled.
- Promoting Park & Ride lots, commuter routes and routes to outlying parts of the Madison urban area (such as Fitchburg and Middleton routes).
- Creating other promotional materials, including public information to increase awareness of Metro.

Overall transit information/promotion program is to be approved by County Public Works & Transportation Committee prior to release of funds.

3. Contribution Toward Operating Costs of Metro Transit

During 2024 Metro Transit plans to continue to focus on employee pass programs (such as the UW and St. Mary's employee passes) and the Commuter Choice Benefit program to attract more county and regional use. Metro will continue to streamline operations after adding Bus Rapid Transit, including 60-foot electric buses, new stops, software, fare technology and more. Additional plans, in 2024, include continuing bus stop sign replacement program and installing maps and schedule information in Metro shelters to make riding Metro easier. This funding will assist Metro with some local share costs of this effort.

Specialized Transportation Coordination. Dane County will fund the following specialized transportation planning and coordination services of the City of Madison to be provided by the Greater Madison MPO (Metropolitan Planning Organization) staff.

- 1) Serve on and provide technical assistance to the Dane County Specialized Transportation Commission, as needed.
- 2) Provide assistance to the <u>Disability & Aging Services Division</u> Adult Community Services Division of the Department of Human Services in planning, coordinating and evaluating their specialized transportation services.
- 3) Assist in monitoring of and collecting data on the operations of specialized transportation providers, and collecting and analyzing data on the location of elderly and persons with disabilities from the American Community Survey and other sources.
- 4) Assist in implementation of the <u>2019-2024</u> Dane County Coordinated Public Transit Human Services Transportation Plan (Coordinated Plan) recommendations.
- 5) Update the Section 5310 Program Management and Recipient Coordination Plan (Program Management Plan) in coordination with Metro Transit and Dane County DHS based on the 2024 Coordinated Plan and updated FTA Circulars 9070 and 5010.
- <u>65</u>) Work with Metro Transit to implement the Section 5310 (Enhanced Mobility for E/D Persons) Program Management and Recipient Coordination Plan, including project scoring and selection by the MPO and administration of the program by Metro.
- <u>76</u>) Coordinate various projects with county agencies and service providers, both public and private, to make Dane County's specialized transportation services more cost-effective.

Staff Comments on Item:

CARPC is once again requesting Federal Planning funds from the Wisconsin Department of Transportation for transportation planning activities for areas in Dane County generally outside of the Madison Metropolitan Area. A total of \$5,457 of this amount (including the local match) will be set aside for MPO planning services. CARPC is requesting that the MPO provide services similar to previous years.

These MPO staff services have historically included conducting analyses of the impact of proposed Sewer Service Area (SSA) amendments in the county on the multi-modal transportation system, including an assessment of the capacity to handle the traffic to be generated, ability to serve the development with public transit, accommodations for pedestrians and bicyclists, other design issues, and overall consistency with the goals, policies, and recommendations in the Regional Transportation Plan. Services in 2025 may or may not include this activity as CARPC is considering eliminating the land use/transportation review of SSA amendments and replacing that with reviews and assistance on comprehensive plans.

MPO staff will provide assistance to CARPC staff in preparing the transportation component of comprehensive plans, and providing other local transportation planning assistance. MPO staff will also assist in preparing consistency reviews of comprehensive plans. MPO staff also continue to coordinate with CARPC on integrating regional land use and transportation planning, including on tracking performance measures and on outreach efforts.

This MPO activity is included in the 2025 MPO Unified Planning Work Program.

MPO 2024 Resolution No. 24

Authorizing the City of Madison to Enter into an Agreement with the Capital Area Regional Planning Commission (CARPC) for the Greater Madison MPO to Provide Transportation Planning Services to CARPC in 2025

WHEREAS, the Greater Madison MPO (Metropolitan Planning Organization) is the designated MPO for the Madison Metropolitan Area with responsibilities to perform metropolitan transportation planning and programming activities; and

WHEREAS, the Capital Area Regional Planning Commission (CARPC) is the regional land use planning and area-wide water quality management planning agency for the Dane County region with responsibilities that include preparing a master framework plan for the physical development of the region; and

WHEREAS, CARPC is in need of services to conduct transportation planning for areas in Dane County, particularly outside of the Madison Metropolitan Area; and

WHEREAS, CARPC is requesting federal Planning funding from the Wisconsin Department of Transportation for transportation planning activities for areas in Dane County outside of the Madison Metropolitan Area; and

WHEREAS, CARPC is also requesting that the Greater Madison MPO provide these services in a similar manner to previous years; and

WHEREAS, these services are to consist of: (1) conducting analyses of the impact of proposed Urban Service Area amendments on the multi-modal transportation system, including capacity to handle the traffic to be generated, ability to serve the development with public transit, accommodations for pedestrians and bicyclists, other design issues, and the overall consistency with the goals, policies, and recommendations in the MPO's Regional Transportation Plan; and (2) coordinating on CARPC's work to finalize and begin implementing the Regional Development Framework plan, including coordination on the performance measures to be used to gauge successful implementation of plan goals and objectives; and

WHEREAS, the MPO will bill CARPC on a quarterly basis for the 80% federal funding share of providing the transportation planning services with the city covering the required 20% local match to the federal funding, and the cost of these services will not to exceed \$5,457 (including the local match) for calendar year 2025; and

WHEREAS, these MPO work activities are included in the adopted 2025 MPO Unified Planning Work Program:

NOW, THEREFORE, BE IT RESOLVED that the Greater Madison MPO authorizes the City of Madison to enter into an agreement with CARPC for the MPO to provide transportation planning services to CARPC in calendar year 2025 with CARPC providing for the reimbursement of MPO staff services for an amount not to exceed \$4,911.

Staff Comments on Item:

This TIP amendment makes several revisions to the 2025-2029 TIP.

First, the amendment removes the Metro Transit Onboard Survey listing. The section 5304 Statewide Planning Grant funded survey was administered in the spring of 2024; although staff is currently processing the results this work is funded through the MPO's general planning funding and the section 5304-funded portion of the project is complete.

Second, it adds a \$3.1 million Metro Transit Route B End of Line Charging infrastructure project (Future section 5307 Urbanized Area Formula Funding Program grant). This project is needed to support the use of battery-electric buses on Route B regardless of whether or when Route B is upgraded to a Bus Rapid Transit route in the future.

Third, it adds a new federally funded railroad crossing safety crossing project, located on Nelson Road (east of Felland Road) in the Town of Burke (sponsored by WisDOT).

Note: In addition to the projects noted above, Item No. 7 of the agenda lists five new Safe Streets and Roads for All (SS4A) projects that were recently awarded funding. These projects are all part of the Safe Streets and Roads for All (SS4A) Planning and Demonstration Grant Application submitted by the MPO. Staff had intended to include these projects in the resolution, but later removed them since FHWA staff indicated earlier this week that they are not required to be in the TIP.

WHEREAS, the new projects are consistent with *Connect Greater Madison: Regional Transportation Plan 2050,* the long-range regional transportation plan for the Madison Metropolitan Planning Area as adopted on May 11, 2022:

NOW, THEREFORE, BE IT RESOLVED that the Greater Madison MPO approves Amendment No. 2 to the 2025-2029 Transportation Improvement Program for the Madison Metropolitan Area & Dane County, making the following project revisions and additions as shown on the attached project listing table:

- 1. **REMOVE** the Metro Transit Onboard Survey Project listing from page 29 of the Transit Capital Projects section.
- 2. <u>ADD</u> the Metro Transit Route B End of Line Charging Infrastructure project to page 29 of the Transit Capital Projects section.

MPO 2024 Resolution No. 26 Approving Return of Unspent Dollars and Amending 2024 UPWP to Reflect the Budget Change

After our previous request for an extension, more commonly known as a carry-forward request, WisDOT and FHWA made it clear that no further requests could be made. This is not unique to the Greater Madison MPO. We have succeeded in spending the full amount of our former carry forward request.

Key elements resulting in unspent funds were staff vacancy, delay of Active Transportation Plan to better complement City of Madison Active Transportation Plan (ATP), delay of Transportation Systems Management and Operations (TSMO) plan contracting for consultant service, and delay of GIS mapping data purchase. The total amount to return is \$77,000.

It is worth noting that the MPO budget works on a reimbursement basis, so the City of Madison, on behalf of the MPO, is not making an actual refund of \$77k. Instead, it is WisDOT to make the funds available to other MPOs within the state.

Status Report on Capital Area Regional Planning Commission (CARPC) Activities

Staff Comments on Item:

- CARPC continues to work on local planning projects, including Comprehensive Plan updates for the Towns of Bristol and Rutland and committee service for neighborhood planning processes in the City of Fitchburg.
- Work on the boundary agreement between the City and Town of Sun Prairie continues we
 expect a public draft by the end of the year and look forward to adoption in Spring 2025. We
 have also been talking to the Town of Westport and its neighbors as the Town pursues
 incorporation.
- CARPC's role as administrator of the Dane County Water Quality Plan was tested this summer
 by the Madison Metropolitan Sewerage District's proposal to comply with phosphorous limits
 in Badger Mill Creek by ending the return of treated wastewater to that watershed. Our
 Commission recommended denial due to uncertainty about the water quality impact of
 reducing stream flow, DNR staff approved the change with some testing and monitoring
 conditions, and the City of Verona has sued, seeking reconsideration of that decision.
